The exhibition & exhibits will be displayed on website www.bakuraphilex.in

Objectives:

- To expand and develop awareness amongst the Philatelic fraternity, particularly amongst the youth.
- To promote every aspect & interest around Philately in Bankura District.
- Four(4) Special Covers will be released in the Exhibition.

BANKURAPEX - 2021



The exhibits & entries will be classified as follows:

1. **NON COMPETITIVE CLASS** - by invitation only (Entries open between 10:00 hrs of 18-11-2021 & 17:00 hrs of 24-11-2021)
2. **COMPETITIVE CLASS**
 - (a) Philatelist
 - (b) Students

ELIGIBILITY FOR PARTICIPATION

- i) Bankurapex-2021 is open for the participants of Bankura District
- ii) A Participant may enter exhibits in one or more than one class . However one entry is permitted in one class. If more than one entry is received under the same class , the allotment committee reserves the right to reject the other entries except any one.
- iii) Exhibits may only be entered under the name of exhibitor and the use of pseudonymous is not permitted
- iv) Every exhibitor must have own his/her exhibits for a minimum of “2 years” before being eligible to participate competitively.
- v) Every exhibitor will to abstain from exhibiting material that does not confirm to the laws of land.
- vi) Exhibitor to apply online on the website www.bakuraphilex.in

All entries should be uploaded in the format as below.

Name of the Participant. Exhibit Title. Page Number. JPEG (e.g.: SanjibDas.Terracotta.P1.JPG)

- i) Sheet Size : a) 23X29 cm(A4) b) 46X29 cm(A3)
In the case of sheet size, 23X29 cm the file size per page should not be more than 800 KB In the case of sheet size 46X29 cm the file size should not be more than 1.6 MB. Example, if the exhibits have three frames.
For each frame separate folder must be created. Example, if the exhibits having three frames, then three folders are required to be sent. The name of the folder will be “Frame 1 to 16” or A4 Size exhibits.
- ii) For letter writing the letter should be restricted to maximum 500 words addressed to The Chief Postmaster General, West Bengal Circle, Kolkata, 700 012 on the theme Rich Cultural Heritage of Bankura/Bishnupur. The letter should be written in A4 size paper and each letter should be uploaded in PDF format. Each entry should contain the name of the competitor, complete address and contact number. No entry will be entertained after the last date i.e. on 24.11.2021 at 17.00 hrs.

Terms & Conditions:

1. All philatelists, students and youth who are residents of Bankura District under Bankura Division are eligible for participating in the COMPETITIVE CLASS of the exhibition.
2. Each exhibits & required stationeries must be the bonafide property of the exhibitor & must abide by the rules and regulations of the exhibition laid down by the Department of Posts and special rules contained herein, if any.
3. Each exhibit in the competitive Class should be entered under the correct category. The allotment committee reserves the right to transfer the incorrectly entered exhibits to the correct category.
4. The organizing committee reserves the right to reject any exhibit completely or partly without assigning any reason for display of any undesirable or unwanted materials. The decision of the committee in this regard will be final.
5. Philately items which have been banned by India Post should not be displayed.
6. Application forms which are incomplete or received after the last date are liable to be rejected.
7. The organizer reserves the right to add, alter or amend any of these rules anytime without any prior notice.
8. The decision of the organizer in all queries connecting the exhibition, other than decisions of the jury shall be final.
9. In the matter arising from jury decisions, the ruling by the Chairman of the Jury shall be final and binding.
10. Submission of online application online by the exhibitor on www.bakuraphilex.in will be deemed to be exhibitor's acceptance of these special regulations of BANKURAPEX - 2021 and all other rules and regulations along with any amendments made thereafter.
11. In Bankurapex - 2021, all competitive exhibits will be judged as per the Department of Post's rules and regulations.

12. No liability/responsibility shall be attached either to the organizers of the exhibition or to the members of the organizing committee, organizing society or its employees or voluntary associates for any loss or damage arising from any cause or reason whatsoever.
13. As the exhibits are uploaded on the website which is available in the public domain, the organizer or organizing committee is not responsible for any copy, photography or downloads of the whole exhibits, exhibit pages or items. Organizing committee cannot prevent the same.
14. For all disputes arising with respect to the exhibition, the decision of the organizing committee shall be final and no appeal will be entertained.
15. A jury committee appointed by the Department of Posts will judge the exhibits. The Jury will have the privilege to consult and consider the opinion of independent professionals in the field. The Jury will have the power to withhold any award, if in its opinion, an entry does not conform to the exhibition standard or for any other reason. Awards or prizes will be decided according to the decision of the Jury.
